"There has been no significant change in the financial or trading position of HBEU and its subsidiary undertakings nor any material adverse change in the prospects of HBEU since 31 December 2022"; and
- replace paragraph 10 of the '*General Information*' section of the Offering Memorandum with the following statement:

"There has been no significant change in the financial or trading position of HBME and its subsidiaries nor any material adverse change in the prospects of HBME since 31 December 2022.".
