This base prospectus supplement (the "**Base Prospectus Supplement**") is supplemental to and must be read in conjunction with the base prospectus dated 9 July 2020 and the supplement thereto dated 11 August 2020 relating to the issuance of Index-Linked Notes and Index-Linked Warrants under the Programme for the Issuance of Notes and Warrants (together the "**Base Prospectus**") prepared by HSBC Bank plc (the "**Issuer**") in connection with the application made for such Notes or Warrants (as applicable) to be admitted to listing on the Official List of the Irish Stock Exchange plc (trading as Euronext Dublin) ("**Euronext Dublin**") and to trading on the regulated market of Euronext Dublin and/or the offer of such Notes or Warrants to the public.
