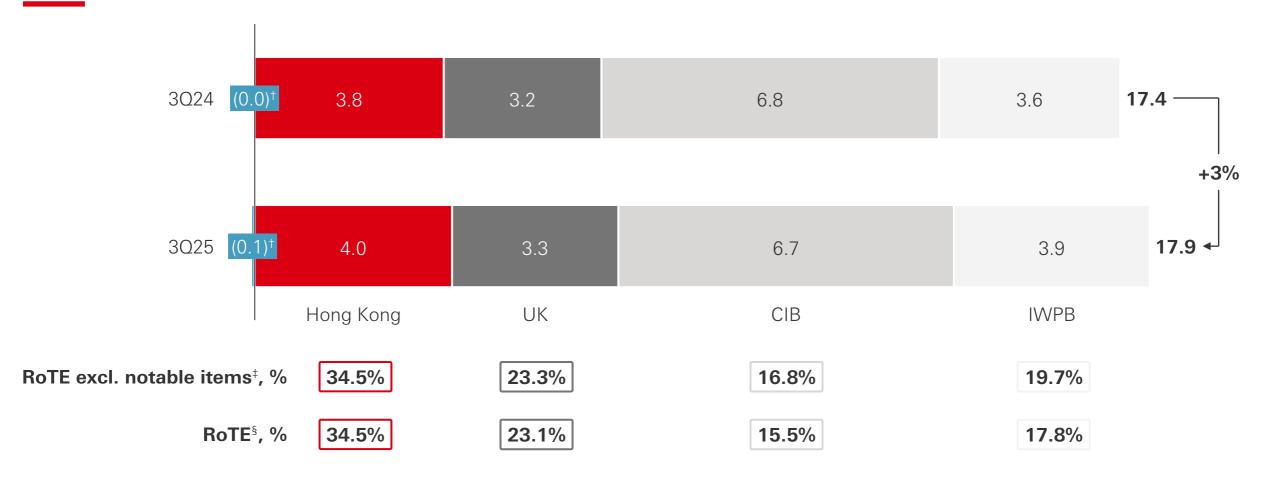

## Revenue\*, \$bn



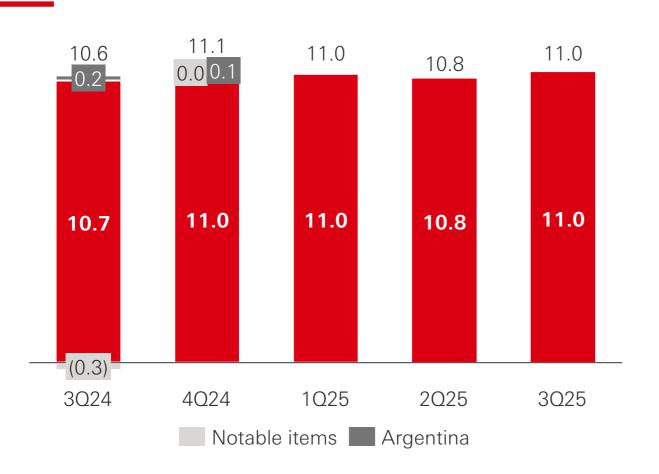

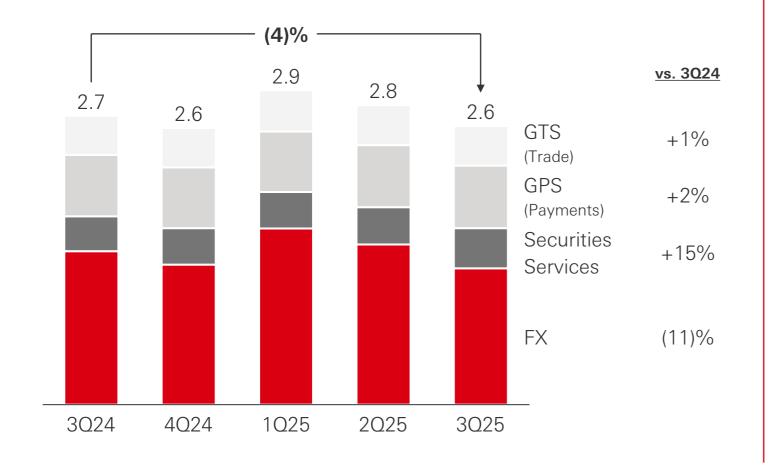

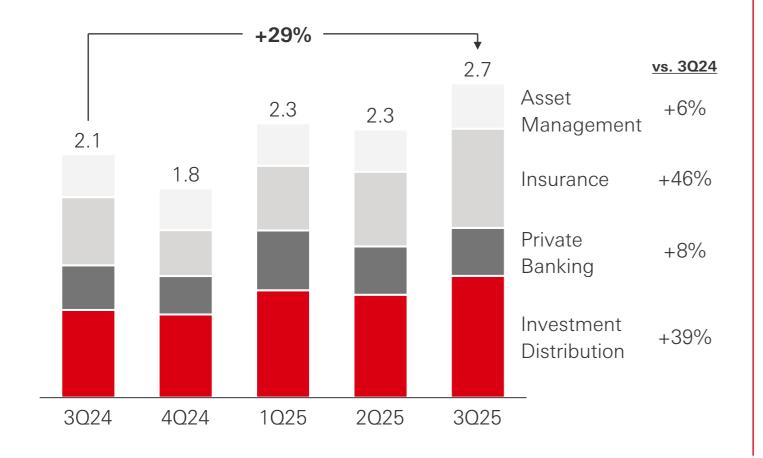

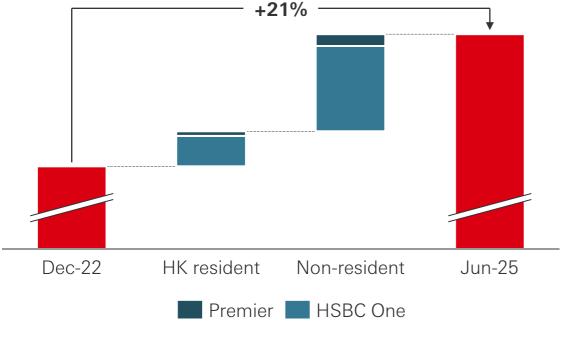

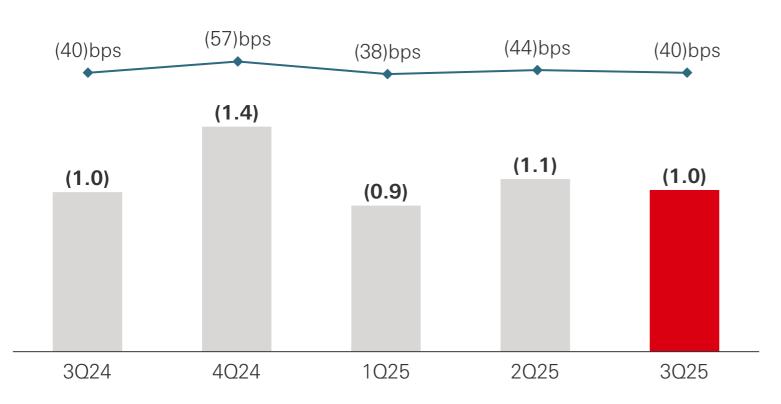

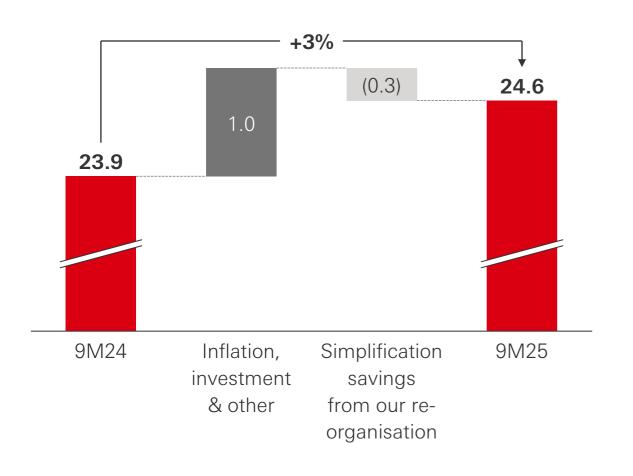

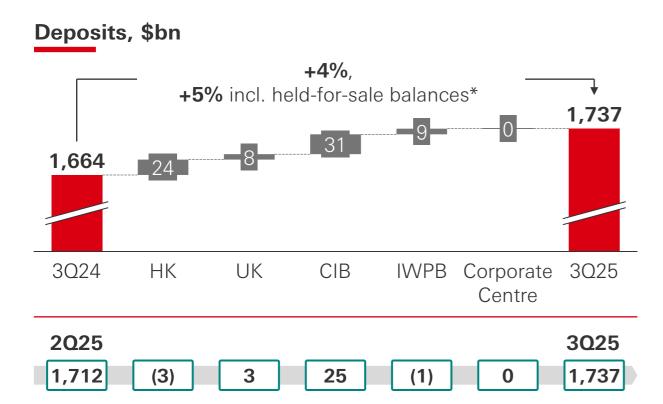

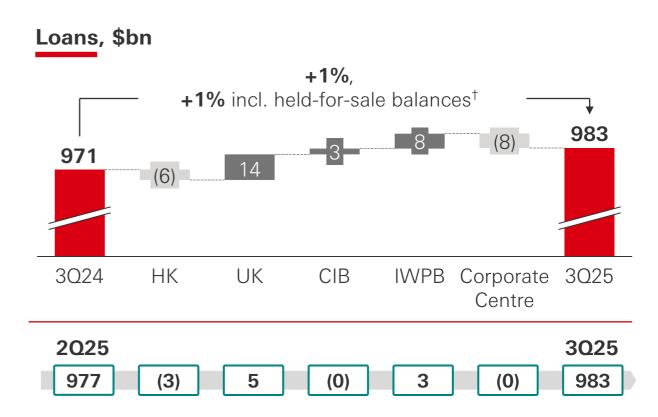

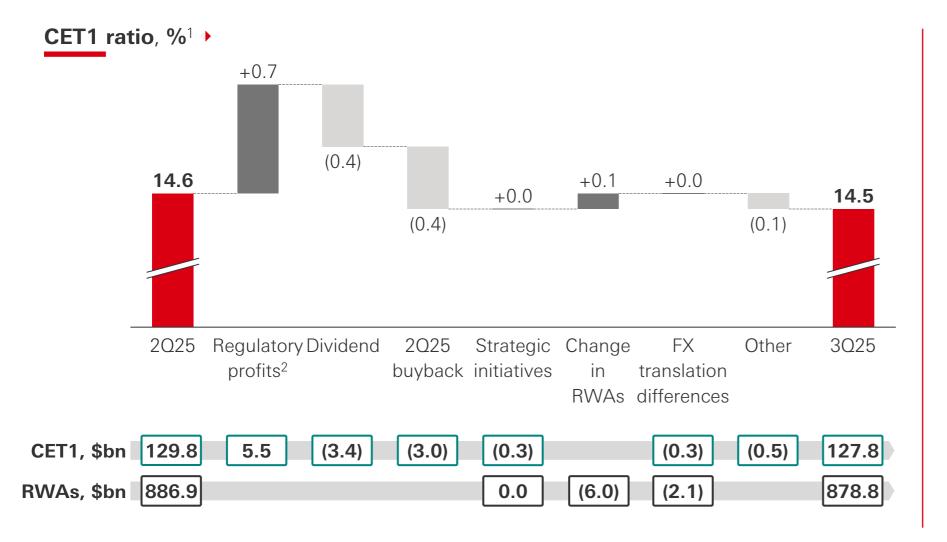

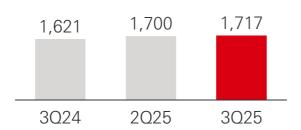

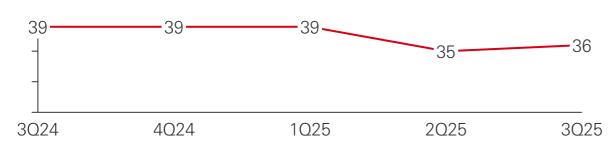

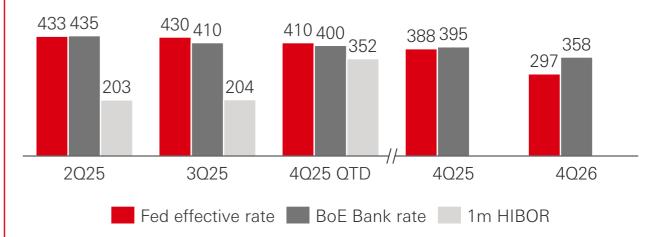
#### Time deposits as a % of Hong Kong customer deposits\*

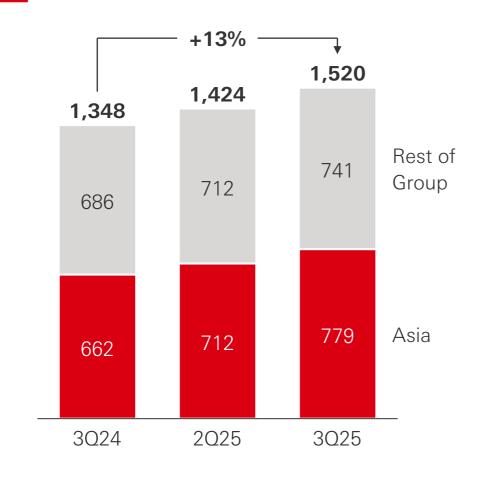

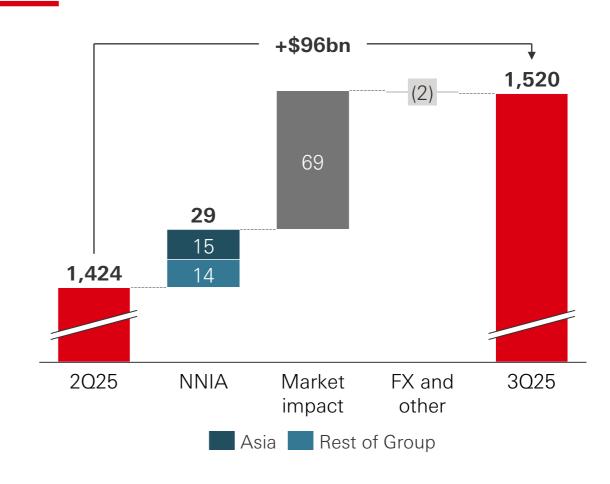

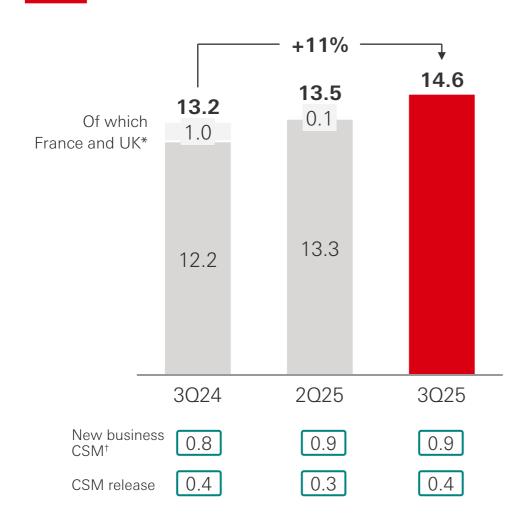

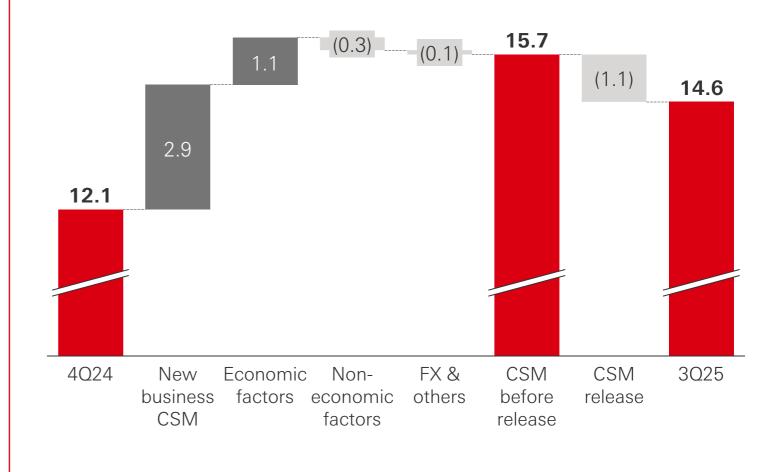
