FOURTH INTERIM DIVIDEND FOR 2012

50,730,560 ordinary shares of US\$0.50 each have been allotted by HSBC Holdings plc to shareholders who elected to receive the scrip dividend alternative for the fourth interim dividend for 2012.

The shares will be issued on 8 May 2013 and will rank pari passu with the existing issued ordinary shares of the Company.
