## **Notes on Environment Data**

- 1 HSBC's 2015 Annual Report and Accounts (ARA) incorrectly states that we applied the revised Greenhouse Gas (GHG) Protocol Scope 2 guidance market based methodology. We have applied our HSBC CO<sub>2</sub> Emissions Reporting Guidance (available at <a href="http://www.hsbc.com/our-approach/reports-and-documentation">http://www.hsbc.com/our-approach/reports-and-documentation</a>). We will be working with our service providers to integrate the revised GHG Protocol Scope 2 guidance into HSBC's reporting methodology and report using both location based and market based methodologies in future periods.
- 2 Following the release of the revised GHG Protocol Scope 2 Guidance, we decided to use the state-specific eGRID emission factors for our US operations until such time as we obtain supplier-specific emission factors. For 2014, therefore, our reported total carbon dioxide emissions have increased by 43,000 tonnes and our carbon dioxide emissions per FTE have increased by 0.16 tonnes.
- 3 Since 2013, our annual data is prepared for the 12 month period to 30 September in accordance with our internal reporting timetable.
- 4 Since Q4 2013, we switched from DEFRA's 5-year grid rolling average emission factors to DEFRA's 1-year grid average emission factors.
- 5 Since 2012, a scale up calculation is made on the basis of the FTE coverage rate to account for any missing data component (typically less than 10% of FTE). In addition, emissions uplift rates are applied to allow for uncertainty on quality and coverage of emissions measurement and estimation.
